AUSTRALIA VISITOR VISA — SUBCLASS 600

The Australian Visitor Visa (Subclass 600) is designed for eligible visitors traveling to Australia temporarily for tourism, visiting family or friends, and other permitted visitor activities.

VISA DETAILS AT A GLANCE

VISA CATEGORY	Visitor Visa — Subclass 600
PURPOSE	Tourism, visiting family/friends and other permitted visitor activities
STAY PERIOD	Determined by the Australian Department of Home Affairs
ENTRY	Single or multiple entry, depending on the visa granted
WORK	Visitor visa holders generally cannot work in Australia
STUDY	Limited study/training may be permitted under visitor visa conditions
DECISION	Final decision rests with the Australian Department of Home Affairs

PERSONAL DOCUMENTS

- ✓ Valid passport
- ✓ Previous passports, where applicable
- ✓ Recent photograph
- ✓ Visa application information
- ✓ Identity and civil-status documents, where relevant

FINANCIAL DOCUMENTS

- ✓ Recent bank statements
- ✓ Salary slips / income evidence
- ✓ Income Tax Returns, where applicable
- ✓ Fixed deposits / investments, where relevant
- ✓ Evidence of available funds for the proposed trip

EMPLOYMENT / BUSINESS DOCUMENTS

- ✓ Employment certificate / NOC
- ✓ Leave approval
- ✓ Salary certificate / payslips
- ✓ Business registration documents, where applicable
- ✓ Business or professional supporting documents

TRAVEL DOCUMENTS

- ✓ Proposed travel itinerary
- ✓ Accommodation details
- ✓ Invitation letter, where applicable
- ✓ Details of intended activities in Australia
- ✓ Previous travel history, where applicable

HOME-COUNTRY TIES

Demonstrating genuine reasons to return after the visit is an important part of a visitor visa application.

- ✓ Employment commitments
- ✓ Business ownership / responsibilities
- ✓ Family commitments
- ✓ Property or asset documents
- ✓ Ongoing financial commitments
- ✓ Educational commitments, where applicable
- ✓ Other relevant ties to the home country

07 — GENUINE VISITOR & HOME-TIES REVIEW Guidance on presenting evidence of temporary visit, financial capacity and commitments/ties outside Australia.	08 — FINAL APPLICATION REVIEW Final review of the complete Subclass 600 application for consistency, completeness and presentation.	09 — BIOMETRIC / SUBMISSION GUIDANCE Guidance regarding biometrics, health examinations or other submission requirements, where applicable.
