TEMPORARY RESIDENT VISA (TRV)

Visitor Visa

For eligible foreign nationals seeking a temporary visit to Canada for tourism, visiting family or friends, attending eligible events, or other permitted short-term visits.

COMMON VISIT PURPOSES

TOURISM — Explore Canada's cities, landmarks and natural beauty.

FAMILY & FRIENDS — Spend quality time with loved ones.

SPECIAL OCCASIONS — Attend eligible weddings and celebrations.

SHORT BUSINESS VISITS — Attend eligible meetings or conferences, subject to requirements.

CANADA VISITOR VISA

Visa Details, Documentation & Professional Support

VISA TYPE	Temporary Resident Visa (Visitor Visa)	PURPOSE	Tourism, family/friends visits, eligible events & permitted short visits
ENTRY	Single or multiple entry, as determined by Canadian authorities	STAY	Authorized period is determined at entry; visitors may generally be permitted to stay for up to 6 months
WORK	A Visitor Visa does not generally authorize employment in Canada	STUDY	A Visitor Visa does not generally authorize long-term study
DECISION	Final decision rests solely with Canadian immigration authorities	IMPORTANT	Visa conditions and authorized stay are determined by Canadian authorities.

- ✓ Photographs as required
- ✓ Completed application information

FINANCIAL

- ✓ Bank statements
- ✓ Salary / income evidence
- ✓ Income Tax Returns, where applicable

EMPLOYMENT / BUSINESS

- ✓ Employment certificate
- ✓ Leave approval / NOC
- ✓ Salary slips / salary certificate
- ✓ Business registration documents, where applicable

PURPOSE OF VISIT

- ✓ Cover letter
- ✓ Proposed travel itinerary
- ✓ Accommodation details
- ✓ Invitation letter, where applicable
- ✓ Relationship documents, where applicable

HOME-COUNTRY TIES

- ✓ Employment or business commitments
- ✓ Family responsibilities
- ✓ Property / asset documents, where relevant
- ✓ Other relevant supporting evidence
