SCHENGEN SHORT-STAY VISA

Schengen Type C visa is for eligible short visits to the Schengen Area, generally allowing a stay of **up to 90 days within any 180-day period**, subject to visa conditions and border rules.

VISA CATEGORY

SHORT-STAY VISA — TYPE C

Tourism, family visits, eligible business and other permitted short stays.

POPULAR DESTINATIONS

France • Italy • Germany • Switzerland • Spain • Greece • Netherlands • Austria • Portugal • Norway • Finland and other Schengen countries

COMMON TRAVEL PURPOSES

TOURISM Holidays, sightseeing and cultural experiences.	FAMILY & FRIENDS Visiting relatives or friends in Europe.	SPECIAL OCCASIONS Eligible weddings, celebrations and events.
BUSINESS Eligible meetings and conferences.	MEDICAL VISITS Permitted short-term medical visits, where applicable.	TRANSIT Applicable transit purposes where a visa is required.

APPLY TO THE CORRECT SCHENGEN COUNTRY

For trips covering multiple Schengen countries, you normally apply through the country that is your **main destination**, based on purpose or longest stay. If no main destination can be determined, the application is generally made through the country of first entry.

SCHENGEN VISA

Visa Details • Documents • Professional Services • Fees

VISA TYPE	Schengen Short-Stay Visa — Type C
MAXIMUM STAY	Up to 90 days within any 180-day period
ENTRIES	Single, double or multiple entry, as indicated on the visa sticker
VALIDITY	Determined by the relevant consulate and shown on the visa sticker
PROCESSING	Normally 15 days; may extend to 45 days where further examination or documents are required
DECISION	Final decision rests with the relevant Schengen country's consulate / authority

- ✓ Previous passports / travel history, where applicable

FINANCIAL

- ✓ Recent bank statements
- ✓ Salary / income evidence

- ✓ Investment / asset documents, where relevant

EMPLOYMENT / BUSINESS

- ✓ Employment certificate / NOC
- ✓ Leave approval
- ✓ Salary slips / salary certificate
- ✓ Business registration documents, where applicable

TRAVEL & ACCOMMODATION

- ✓ Travel itinerary
- ✓ Flight / travel plan, where required
- ✓ Hotel / accommodation details
- ✓ Invitation letter, where applicable
- ✓ Travel medical insurance

PURPOSE & HOME-COUNTRY TIES

- ✓ Cover letter explaining purpose and circumstances of travel
- ✓ Proof of family, employment, business or other relevant ties
- ✓ Property / asset documents, where relevant
- ✓ Additional documents requested by the consulate

Exact requirements vary by destination country, applicant profile and travel purpose. Additional documents may be requested.

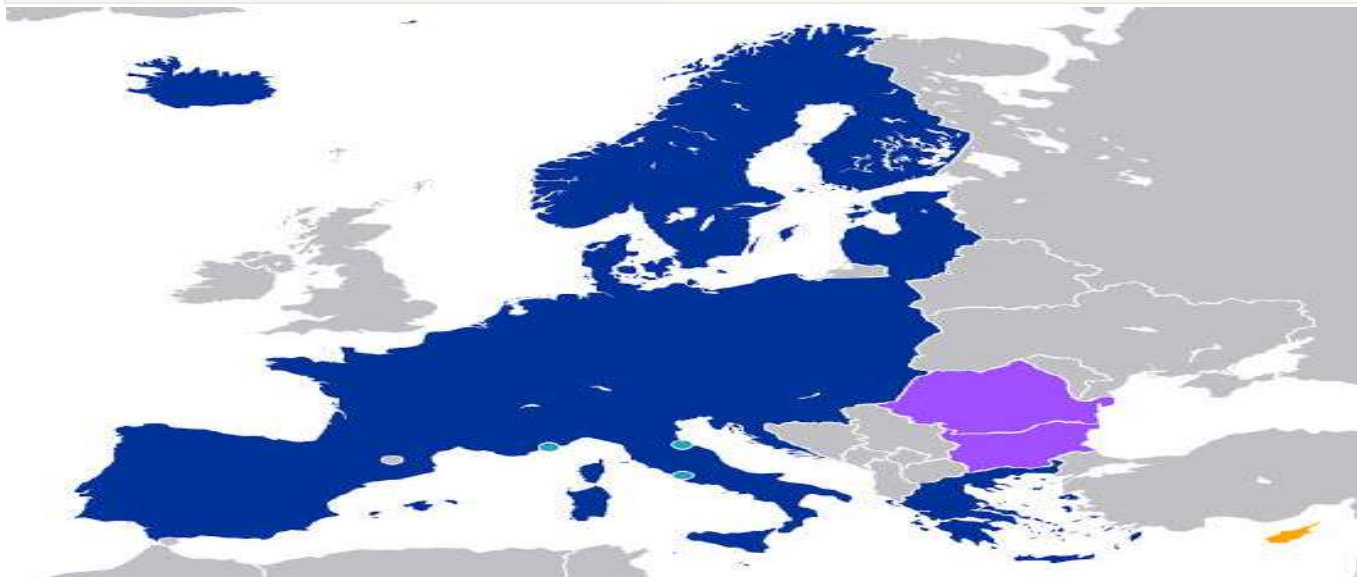
